

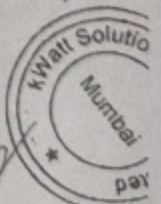

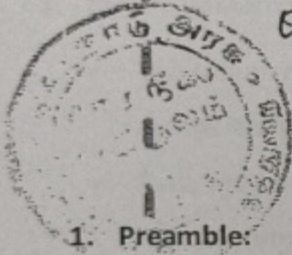

1. Preamble:

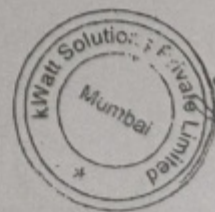

LTD.(kSPL) incubated with Society for Innovation & Entrepreneurship (SINE), IIT-Bombay that perform designing, engineering, installation and after-sales service of solar laboratory systems, solar energy products and other energy saving solutions, customized for specific applications (domestic to commercial) and training to the students and faculties in Solar energy field.

This Agreement results in binding of both the parties to setup a training center which will create Suryamitra and provide trainings to students on roles & responsibilities & association terms as defined on project-to-project basis.

kWatt Solutions Pvt. Ltd. (kSPL) and Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR will sign an agreement to conduct "Suryamitra" solar training program. Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR will provide all the basic infrastructure facilities for the training program and kWatt Solutions Pvt. Ltd. conduct the training program required for trainees during the tenure of training program.

2. Essential Terms of MoU:

- kSPL is responsible for conducting all the training programs of Suryamitra course providing training kits, tools and other training related experimental equipment's.
- Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR will bear the training stationary equipment's such as Projector, White boards and Markers.
- Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR will bear the Electricity charges, Water charges used during the training Program.
- kSPL will pay Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR for using the infrastructure for training, Practical sessions and accommodation on monthly basis.
- kSPL will pay Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR for arranging the Food facility and other food related expenses.

3. Rent Commercial:


- The commercials mentioned are on monthly basis and will be recurring for the period of time the centre is used by kSPL.
- Rent will be transferred to Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR on Monthly basis at the end of each month.
- kSPL will be responsible for the procurement and installation of 1.2kWp ground mounted PV plant for experimental purpose with following details.

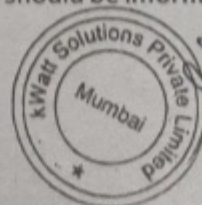

- 2% TDS will be deducted on total bill
- Accommodation charges per bed per day will be Rs.190 +18% GST. If charged monthly basis, the monthly charges per bed will be Rs.6726/- including GST (If availed)
- A Computer laboratory charges (with approximate 30 systems) for training on simulation software will be Rs. 4000/day for 8 hrs. Lab allocation request should be given 2 days in advance.



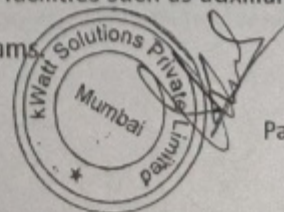
1. 1kWp PV Modules
2. Inverter

Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR will provide basic infrastructure facilities as mentioned below for the lab room, classroom, Terrace/Ground area for practical purpose of approximately 1200 Sq.ft overall.

- a) A dedicated solar experiment lab Accommodating around 30 students 300 sq.ft to perform hands on practical sessions (sufficient enough for the students to perform the experiments)
- b) A lecture/seminar room accommodating around 30 Students 300 sq.ft for theoretical sessions and conducting seminar.
- c) Hostel facility will be provided based on the availability.
- d) In exceptional cases, whenever the training is held out of the campus Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR will suggest to avail with local travels, PMC will introduce the service provider which cost will be borne by KSPL
- e) Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR will provide the open area for Morning activity such as Yoga/PT during the time of Training program
 - Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR is responsible for providing food, accommodation and other basic amenities to trainees and trainers.
 - Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR will provide infrastructure, necessary civil work for foundation and other electrical facilities such as auxiliary power supply (single or three phase) during the training programs.

4. Effective Date and Term:

The MOU is effective from 9th October 2024 for a period of 2 year.

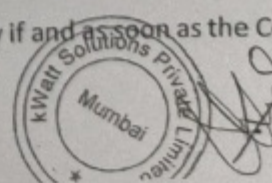

5. Confidentiality:

The parties will disclose information of both commercial and technical nature. The information will be disclosed orally, on tangible data or information carriers (e. g. written documents or drawings), electronically (e. g. in the form of electronic files or programs) or by submitting objects (e. g. machinery, mechanical or electronic components or assemblies). This information may contain trade secrets of significant business importance. This information is considered confidential and will be referred to as "Confidential Information" in the following.

kSPL and Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR shall not use the disclosed Confidential Information other than for carrying out the purpose of this MoU. In particular, they agree not to communicate or disclose the Confidential Information to any third party, use the Confidential Information as a subject for developments of their own, and not to use the Confidential Information to enhance their own products, use the Confidential Information as the subject of applications for intellectual property rights and use the Confidential Information to oppose applications for intellectual property rights of the disclosing party. Furthermore, the parties agree to treat the content of this MoU as confidential towards any other party.

kSPL and Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR shall make accessible Confidential Information (in particular copies of written documents containing Confidential Information and Confidential Information stored on data carriers or submitting objects) only to those employees and consultants who are involved in implementing the purpose of this MoU and need the Confidential Information for carrying out their associated tasks. On these persons the secrecy obligations of this Confidentiality Agreement shall be imposed, even beyond their employment or contractual relationship.

The obligation of confidentiality and restrictions of use no longer apply if and as soon as the Confidential



Information is or becomes public knowledge without breach of this Confidentiality Agreement (including the disclosure by the disclosing party to a third party without obligation of confidentiality) or the recipient can prove to have been in possession of the Confidential Information prior to receiving the information from the disclosing party; in this case, the recipient should inform the disclosing party of such prior knowledge, or the Confidential Information has lawfully been disclosed to the recipient by a third party without obligation to treat the information as confidential, or the recipient realized or acquired the Confidential Information independently of the disclosing party, or a court or an administrative or government authority requests the recipient to disclose the Confidential Information or the recipient must disclose it pursuant to applicable laws.

6. Miscellaneous:


If any term of this MOU is or becomes invalid in total or in part, this shall not have any effect on the validity of the remaining terms of this MOU. In such a case, the parties shall cooperate to agree on a new provision that is as close to the invalid provision in economic terms as legally admissible.

All terms agreed between KSPL and Er. PERUMAL MANIMEKALAI POLYTECHNIC COLLEGE, HOSUR relating to the subject of this MOU has been recorded in writing. There are no further oral provisions made. Any amendment to this MOU must be made in writing to be valid. Any waiver of this written form requirement must be made in writing.

All legal relationships arising from this MOU for the parties shall be governed by the law of India. Exclusive place of jurisdiction for all disputes arising from this MOU shall be Mumbai.


