**2. The interaction between HIA and PMCP shall Broadly include the following categories that can be provided by PMCP to HIA;**


- I. Training Industry members of **HIA** in new technologies in the fields of Data management and other areas of interest.

- This MoU shall be terminated at any time without any liability by giving 3 months prior notice from either party.


